POSITION PURPOSE

Reporting to the Regional Lead – Corporate Services & CFO, the Director - Financial Reporting works closely with the Director – Financial Planning to ensure the efficient and accurate function of financial processes within Southern Health-Santé Sud.

Through a collaborative approach, the Director - Financial Reporting provides leadership for regional financial processes, supervises the work of the staff involved in those processes, prepares the appropriate financial reports and leads the annual audit process. This position also supports organizational accountability and data quality by facilitating the implementation of regional finance best practices, monitoring and analyzing ongoing financial operating results, and providing recommendations for the resolution of finance issues.

The incumbent exercises the appropriate level of initiative and independent judgment in determining work priorities, work methods to be employed and action to be taken on unusual matters. The position functions in a manner that is consistent with the mission, vision and values; and the policies of Southern Health-Santé Sud.

ESSENTIAL FUNCTIONS AND BASIC DUTIES

Duties and functions include but are not limited to the following:

- Responsible for ensuring standardized financial and accounting processes across the organization that are executed in accordance with the organization's policies, procedures and controls.
- Directs activities associated with the management of the organization's financial assets, including capital assets. Ensures all accounting and transaction processing activities are performed effectively with efficiency and integrity. Oversees the preparation of accurate, validated reporting to meet regulatory needs in a timely fashion.
- Directs all communication, planning and processes associated with the annual financial audit.
- Primary contact with Manitoba Health for funding and reporting matters.
- Ensures the development of effective banking and cash flow forecasting model. Makes recommendations on the use of short-term instruments for both investment of excess cash. Ensures the development and implementation of a system of internal controls that effectively manages the financial risks of the RHA.
- Evaluates external factors that could impact the long term financial plans established by the RHA.
- Contributes to making the organization safe for patients, residents, clients and staff, and recognizes the importance of reporting unsafe situations and participating in follow up reviews as a learning opportunity.
- Pursuant to the Regional Health Authority Act, Southern Health-Santé Sud is designated bilingual (English/French). Accordingly, all employees accept responsibility to support clients in their official language of choice.
- Performs other duties as assigned.
