### REPORTING RELATIONSHIPS

### POSITION PURPOSE

The Indigenous Community Worker (ICW) assists First Nations, Métis and Inuit clients/families to access culturally safe care and navigate the mental health and addictions system while engaged in recovery services in Southern Health-Santé Sud. The position will work directly with clients supported in the Mobile Withdrawal Management Services (MWMS) team based in Portage la Prairie, with travel to other areas in the region according to identified need.

The Indigenous Community Worker facilitates and supports communication between clients/families/health care providers as they seek care for their management of substance use and recovery journey. The role is integrated into the MWMS team to ensure Indigenous focused supports are provided whilst receiving care via the MWMS team. This includes interpretation services, personal supports and/or counselling related to recovery and linkages with external health care providers. The ICW participates and engages in client/family care meetings, MWMS team meetings, and acts in accordance with Southern Health-Santé Sud policies and procedures.

The incumbent exercises the appropriate level of initiative and independent judgment in determining work priorities, work methods to be employed and action to be taken on unusual matters. The position functions in a manner that is consistent with the mission, vision and values; and the policies of Southern Health-Santé Sud.

## ESSENTIAL FUNCTIONS AND BASIC DUTIES

Duties and functions include but are not limited to the following:

- Performs duties congruent with Southern Health-Santé Sud Core Values of Integrity, Compassion, Excellence and Respect.
- Helps create a welcoming and positive experience for clients while they are engaging with the MWMS team and utilizing Southern Health-Santé Sud services.
- Receives and implements referrals from the MWMS Health & Social Service Coordinator for those seeking supports with their withdrawal management and ongoing recovery.
- Interprets or facilitates interpreter services for Indigenous clients/families and health care providers.
- Assists clients/families with facilitating culturally relevant care and ceremony.
- Provides liaison to interdisciplinary teams, community health and social agencies.
- Facilitates client/family participation in care by providing information about various programs and resources.
- Helps Indigenous clients/families receiving withdrawal management services become self-advocates, experts and decision-makers around their own health by providing clients/families with access to information that will support them with decision-making.
- Functions as a member of an interdisciplinary team with the Rapid Access to Addiction Medicine Clinic to help facilitate service that is culturally sensitive and therefore more productive and meaningful to the client.
- Responsible for communicating effectively, consulting and collaborating with members of the MWMS team.
- Works collaboratively with other health care professionals and community organizations on issues and problems within the health care system related to substance use to improve services for Indigenous clients/families.
- Provides referral information for various services, e.g. Mental Health, Support Services, Social Work, Palliative Care, etc.
- Establishes an effective working relationship with client/family.
- Establishes and maintains professional boundaries with client/family while refraining from imposing own beliefs, values and lifestyle on client/family.
- Mediates concerns between client/family and the MWMS team as well as larger health system concerns.
- Provides service to Indigenous clients in other Southern Health-Santé Sud locations as assigned.
- Participates in the planning and evaluation of care.
- Inputs data collection, analysis and evaluation of activity statistics related to client contact and interactions.
- Documents in the health record and communicates accurate information, observations and interventions in a timely manner.
- Exercises initiative in carrying out tasks and demonstrates sound judgement and time management skills.
- Uses critical thinking skills to guide decision making within scope of responsibility.
- Recognizes own level of competency and seeks appropriate direction or assistance.

- Reports pertinent information to the supervising position.
- Pursues opportunities to develop and enhance individual knowledge, skills and abilities.
- Identifies learning and development needs through self-assessment, peer feedback, and trends in current practice.
- Participates in continuing education to ensure skills are maintained and enhanced.
- Adheres to all Southern Health-Santé Sud policies and procedures.
- Maintains confidentiality in all matters relating to clients, staff and the organization.
- Contributes to making the organization safe for patients, residents, clients and staff, and recognizes the importance of reporting unsafe situations and participating in follow up reviews as a learning opportunity.
- Pursuant to the Regional Health Authority Act, Southern Health-Santé Sud is designated bilingual (English/French). Accordingly, all employees accept responsibility to support clients in their official language of choice.
- Performs other duties as assigned.

*Responsibilities and accountabilities are assigned in broad organizational objectives. The position is subject to review of general effectiveness and attainment of objectives through performance measurements.*

## **QUALIFICATIONS**

Education/Certification:

- Grade twelve (12) high school education or equivalent (e.g. GED).

Knowledge required:

- Knowledge of Indigenous and Non-Indigenous services and resources.
- Knowledge of health issues impacting Indigenous communities. Specific knowledge in substance use impacting Indigenous communities is an asset.
- Knowledge of Indigenous world views.
- Knowledge and proficiency in Microsoft Office and Outlook applications.

Experience required:

- Minimum of two (2) years experience working with Indigenous people in a social service setting.

## Skills/Competencies/Conditions of employment:

- Demonstrated proficiency in a local Indigenous language (Ojibway, Dakota, Cree).
- Demonstrated excellent interpersonal and communication skills.
- Demonstrated excellent problem-solving skills.
- Demonstrated ability to work with minimal supervision both independently and as part of a team.
- Demonstrated ability to take initiative and anticipate needs.
- Given the cultural diversity of our region, the ability to respect and promote a culturally diverse population is required.
- Proficiency of both official languages is essential for target and designated bilingual positions
- Demonstrated ability to respect confidentiality including paper, electronic formats and other mediums.
- Demonstrated ability to meet the physical and mental demands of the job.
- Good work and attendance record.
- Completes and maintains a satisfactory Criminal Record Check, Vulnerable Sector Search, Adult Abuse Registry Check and Child Abuse Registry Check, as appropriate.
- All Health Care Workers are required to be immunized as a condition of employment in accordance with Southern Health-Santé Sud policy.
- Requires a valid Class 5 driver's license, an all purpose insured vehicle and liability insurance of at least \$1,000,000.

## WORK CONDITIONS

- No hazardous or significantly unpleasant conditions.
- May work occasionally evenings and weekends as necessary.
- Will be required to travel to other regional facilities as the position duties may require.
