### **POSITION PURPOSE**

Reporting directly to the Regional Lead – Corporate Services & CFO, the Manager, Project & Facilities, is responsible for the following functions: project management of all capital projects that are planned for the organization and for plant operations throughout the region. Primary responsibilities relate to departmental management, human resource management, fiscal management, policy development, program planning, project planning, quality management, equipment/supplies/space management, inservice/education, professional development, environmental management, committee participation and communication.

The incumbent will exercise the appropriate level of initiative and independent judgment in determining work priorities, work methods to be employed and action to be taken on unusual matters. The position functions in a manner that is consistent with the mission, vision and values; and the policies of Southern Health-Santé Sud.

### **ESSENTIAL FUNCTIONS AND BASIC DUTIES**

Duties and functions include but are not limited to the following:

- Assist in the identification, prioritization and coordination of an ongoing strategic capital plan for the region.
- Ensures all capital projects are planned to incorporate LEED building design and CSA Infection Control measures.
- Coordinates all capital and safety security projects for the region including planning, implementation, and evaluation of all projects.

- Establishes programs and processes with regard to architectural design services, construction management contracts and management of contract terms.
- Plans, coordinates and supervises the work of outside contractors and ensures all work is being done in accordance with federal, provincial and municipal codes, regulations and standards, including Workplace Safety & Health regulations.
- Monitors progress of each project and performs regular inspections to ensure contract compliance and that the project plan, including budget, schedule and quality are being maintained.
- Ensures project status and design and construction issues presented by internal and external stakeholders are being addressed in a timely and collaborative manner.
- Facilitates ongoing collaboration and communication with all internal and external stakeholders throughout all phases of a capital project.
- Prepares, manages and reports regularly on the program status to all stakeholders.
- Participates in the development, review and revision of regional, program and departmental
  policies and procedures, including the implementation of policy directives and established
  feedback mechanisms.
- Ensures that there are departmental goals and objectives established for maintenance that align with organizational strategic priorities.
- Oversees the management of minor on-site construction/renovation projects.
- Ensures compliance with all relevant legislation, including fire codes, building codes, labour codes, health and safety laws and environmental laws.
- Prepares annual departmental capital and operating budget for staffing levels and equipment needs.
- Monitors departmental budgets on a regular basis and takes corrective action as necessary, and prepares variance analysis as appropriate.
- Manages human resources within the department and interprets and applies regional policies and collective agreements where applicable.
- Participates as a member of the Regional Management Team and in collaboration, develops, organizes, implements and evaluates a continuous improvement / risk management / utilization review program including: the establishment of objectives and criteria; participation in the process review; development of procedures; documenting activities indicating corrective actions taken; ensuring participation of all staff; presenting reports on findings; and monitors, evaluates and improves productivity and outcome measurement tools.
- Assists in the management of furniture and equipment procurement.
- Reports immediately on any situations that may pose safety or fire hazards and recommends measures to ensure safety of workers, residents and staff.
- Recommends measures to ensure that all materials and supplies stored on-site are not subjected to theft, fire or vandalism.
- Performs related duties as assigned by the Vice President Finance & Planning.
- Contributes to making the organization safe for clients, and recognizes the importance of reporting unsafe situations and participating in follow up reviews as a learning opportunity.

- Effective leadership ability including achieving operational objectives (programmatic, financial and human resource management) in a results-based, multiple site/program environment

- Strong organizational skills and flexibility to meet the demands of the position
