POSITION PURPOSE

The Regional Coordinator – Medical Device Reprocessing (MDR) is responsible for providing regional coordination for the Medical Device Reprocessing program and related clinical settings. This individual will assist with planning and supporting the region with quality reprocessing of reusable medical devices in collaboration with the Manager, Health Services. The incumbent provides program direction in Medical Device Reprocessing to meet the Canadian Standards Association (CSA), Infection Prevention and Control Standards, and Accredited Canada standards, integration of quality improvement, risk management, patient safety, and education.

The incumbent exercises the appropriate level of initiative and independent judgment in determining work priorities, work methods to be employed and action to be taken on unusual matters. The position functions in a manner that is consistent with the mission, vision and values; and the policies of Southern Health-Santé Sud.

ESSENTIAL FUNCTIONS AND BASIC DUTIES

Duties and functions include but are not limited to the following:

- Applies evidence-based standards and best practices including health care research in the policies, guidelines and protocols to ensure standards are met for medical device reprocessing.
- Responsible for the development, revisions and monitoring the clinical policies, guidelines and protocols related to Medical Device Reprocessing.
- Develops an education and roll out plan in collaboration with Staff Development Program for the Medical Device Reprocessing sites to operationalize new or revised policies, guidelines and protocols.

- Participates in the Quality Improvement, Patient Safety and Risk Management activities as it pertains to Medical Device Reprocessing.
- Participates in special projects as it relates to the Medical Device Reprocessing program.
- Provides a monthly report of activities to the Manager, Health Services.
- Participates in the budget planning process as part of the Regional Acute Care team.
- Contributes to making the organization safe for patients, residents, clients and staff, and recognizes the importance of reporting unsafe situations and participating in follow up reviews as a learning opportunity.
- Pursuant to the Regional Health Authority Act, Southern Health-Santé Sud is designated bilingual (English/French). Accordingly, all employees accept responsibility to support clients in their official language of choice.
- Performs other duties as assigned.

2. Leadership

- Carries out professional activities in a self-directed responsible manner, which reflects legal, ethical and practice standards.
- Collaborates with all disciplines to facilitate an efficient, effective Reprocessing in the MDR department.
- Participates in the Provincial MDR Committee and other health care programs/sites, partner agencies, to keep abreast of practice issues and changes in the delivery of care.
- Facilitates an environment which fosters change that is in keeping with the Regional Board Ends/Core Values, philosophy and strategic plans.
- Facilitates a positive work environment through valuing and operationalizing an empowered model of professional practice in Infection Control and Medical Device Reprocessing standards and practices.
- Acts as a resource to staff in MDR decision-making utilizing the decision making process, professional conceptual frameworks and appropriate resources.

- Facilitates professional growth and ensures that educational opportunities are provided for the staff in collaboration with the Staff Development Program.
- Coaches, advises and supports staff in achievement of identified professional goals and objectives.
- Facilitates educational support and orientation of MDR departments within Southern Health-Santé Sud as required.
- Collaborates with Staff Development and Infection Prevention and Control programs to ensure education of MDR practice changes are incorporated throughout the respective sites in the region.
- Demonstrates creativity, adaptability and critical thinking skills in order to influence and sustain change and a positive work environment.
- Active participant in selection and evaluation of MDR production and surgical equipment, instruments and MDR supplies.
- Demonstrates a working knowledge of Workplace Hazardous Materials Information systems (WHMIS) and adheres to procedures for handling and storing controlled substances as described in the Material Safety Data Sheets (MSDS).

3. Quality Improvement

- Articulates and operationalizes the philosophy, concepts and processes of quality improvement consistent with that of the region.
- Identifies, in collaboration with others, the need for revised policies, procedures and guidelines within the Medical Device Reprocessing Program through the Regional Surgery Team process.
- Participates in occurrences and risk management situations, and implements appropriate follow up in collaboration with the Manager, Health Services.
- Creates and implements audits related to the areas of responsibility and shares results with MDR and Regional surgery program team, Directors and regional stakeholders.

4. Professional Responsibility and Accountability

- Responsible and accountable for professional practice and conduct.
- Maintains license through the College of Registered Nurses of Manitoba and other professional organizations related to area of specialization.

5. Indicators

- Maintains current practicing registration with CRNM.
- Identifies and responds to professional practice issues that interfere with the ability to
 practice according to standards and code of ethics and which could have an injurious effect
 on the client or others.
- Takes personal responsibility for professional conduct and fitness to practice.
- Promotes a practice environment that supports professional responsibility, accountability, and development.

QUALIFICATIONS

EDUCATION/CERTIFICATION:

- Baccalaureate Degree in Nursing (Masters preferred).
- Health Care Management and/or Health Care Leadership Certification an Asset.

- Professional Licensure in good standing with the applicable College or Professional Association and the scope of practice as defined by the Regulated Health Professions Act (RHPA).
- Successful completion of a recognized accredited Medical Device Sterile Supply Reprocessing Program.

• Comprehensive knowledge of theory, practice and research in relation to clinical area.

EXPERIENCE REQUIRED:

- Minimum of ten (10) years nursing experience with demonstrated competency in a variety of clinical nursing settings inclusive of a comprehensive knowledge of theory and practice related to Acute Care.
- A minimum of five (5) years' experience within the past seven (7) years demonstrated in management and leadership skills.

- Demonstrated leadership skills.
- Demonstrated ability to problem-solve in complex situations and effectively manage rapidly changing situations.
- Demonstrated effective collaboration, negotiation, and conflict resolution skills.

- Demonstrated written and oral communication skills.
- Demonstrated computer literacy in software programs.
- Demonstrated organizational, decision making and problem solving skills.
