Vitamin & Mineral Supplements PCH Formulary Changes Effective February 1, 2025

Based on the evidence presented in the *Vitamin and Mineral Supplementation in LTC: Quick Reference Guide (Oct 2024),* the table below outlines the changes to the vitamin and mineral supplements on the PCH Drug Benefit List (formulary) which will come into effect on February 1, 2025.

From October 2024 to January 2025, prescribers, pharmacists, dietitians, and nurses should identify residents on the vitamin and mineral supplements listed in the third column as these products will be removed from the PCH formulary (i.e., no longer covered in PCH).

For residents on the vitamin and mineral supplements which will no longer be covered, determine:

- 1) Is the supplement required or can it be discontinued?
- 2) Is there an alternative supplement listed which is covered? For some micronutrients, supplementation via a multivitamin with minerals may provide sufficient amounts instead of a single ingredient supplement.
- 3) Does the resident/family want to continue on the supplement and pay for it?
