# STANDARD GUIDELINE SUBJECT:

Forced Air Warming System – Bair Paws

#### PURPOSE:

The purpose of the guideline is to outline a standardized process to mitigate risk of surgical patients developing perioperative hypothermia, cardiac complications, infections and blood loss.

#### **DEFINITIONS:**

Hypothermia: Defined as a core body temperature of less than 36 degrees Celsius.

### PROCEDURE:

Criteria for use:

Bair Paws gowns will be applied to patients undergoing the following procedures:

- All joint replacements (hip, knee and shoulder)
- Spine surgery
- Caesarean sections
- Bowel resections
- ➢ Hip fracture repair
- Open cholecystetomy

#### Contraindications:

In the presence of transdermal medication, Bair Paws should be avoided or the transdermal patch relocated. This will mitigate the enhanced absorption of the drug from the Bair Paws.

### Pre-Op:

To apply Bair Paws

- 1. Connect Bair Paws hose to Bair Paws gown.
- 2. Place Bair Paws gown on patient.
- 3. Turn Bair Paws on.
- 4. Turn temperature guide to desired setting.
- 5. Do not place any clothing or blankets between the patient and the gown.
- 6. Monitor patient, including temperature and vital signs prior to gown being applied and 15 minutes following.
- 7. Instruct patient on how to use temperature guide.

Post anesthetic Care Unit (PACU):

- 1. The patient's temperature should be measured and documented on admission to PACU and then every 15 minutes.
- 2. If the patient's temperature is below 36 degrees Celsius, the patient is actively warmed using Bair Paws until discharged from PACU or until they are comfortably warm.
- 3. The patient will not be transferred to the nursing unit unless their temperature is 36 degrees Celsius or above.

Post-Op:

- 1. The patient's temperature and vital signs are monitored every 15 minutes until the patient is able to verbally communicate temperature sensation and has a sense of feeling comfortable.
- 2. Once this has been achieved, temperature and vital signs should be measured every 30 minutes while the Bair Paws gown is in use.
- 3. Discontinue use of Bair Paws with the temperature stabilized at 36 degree Celsius or above.

Documentation should include the following:

- Patient and family education,
- > Patient's temperature and site of temperature assessment,
- ➤ Vital Signs,
- Physical assessment findings,
- > Time of warming initiated and terminated,
- Patient comfort level,
- > Unexpected outcomes,
- > Additional interventions.
