
Medication Reconciliation: Quick Reference Guide




Transition Home to Acute Care facility

- Acute Care facility completes the "Best Possible Medication History and Admission Reconciliation & Order Form".
- The prescriber signed form becomes the admission orders to the acute care facility.
- Fax /scan the admission orders to the pharmacy.




Transition Acute Care facility to Home

- Use the original "Best Possible Medication History and Admission Reconciliation & Order Form" and the current MAR and New medications to be started upon discharge to complete the "Discharge Medication Plan and Prescription"
- The prescriber signed form is a legal prescription that can either be faxed or given to the patient for their community pharmacy.




Transition PCH /Transitional site to a different PCH/Transitional site

- Sending PCH/Transitional site provides a copy of the current MAR.
- Receiving PCH /Transitional site uses the current MAR to complete the "Best Possible Medication History and Admission Reconciliation & Order Form".
- The receiving PCH/Transitional site prescriber signed form is faxed to the pharmacy at least 2 business days in advance.




Transition Acute Care to a different Acute Care facility

- Sending facility provides a copy of the current MAR and original "Best Possible Medication History (BPMH) and Admission Reconciliation & Order Form"
- Receiving facility uses the information to complete a new "Best Possible Medication History and Admission Reconciliation & Order Form".
- The prescriber signed form is faxed/scanned to the pharmacy to be filled.




Transition Home to Personal Care Home (PCH)/Transitional

- PCH/Transitional site or consultant pharmacist completes the "Best Possible Medication History and Admission Reconciliation & Order Form".
- The PCH/Transitional site prescriber signed form becomes the admission orders to the PCH/Transitional site.
- Fax the admission orders to the pharmacy. Admission orders to be completed and sent to pharmacy at least 2 business days in advance of transition.




Transition Acute Care facility to PCH/Transitional site

- Acute Care facility uses the original "Best Possible Medication History and Admission Reconciliation & Order Form" and the current MAR to complete the "Discharge Medication Plan and Prescription"
- The Acute Care facility prescriber signed form is the admission orders to the PCH/Transitional site (PCH with contract pharmacy may differ)
- Fax the orders to the pharmacy at least 2 business days in advance of transition.



Transition PCH/Transitional site to Acute Care facility

- Sending PCH/Transitional site provides a copy of the current MAR .
- Receiving facility uses the current MAR to complete the "Best Possible Medication History and Admission Reconciliation & Order Form".
- The acute care facility prescriber signed form is faxed/ scanned to the pharmacy to be filled.



Transition from 1 unit to another in the same Acute Care facility

- The sending unit's current MAR medication list are transcribed onto the "Transfer Reconciliation and Order Form".
- The prescriber signed form becomes the orders on the receiving unit.
- Fax/Scan the "Transfer Reconciliation and Order Form". orders to the pharmacy to be filled.
